Ms. Gandy routinely advises families whose children have experienced harm at school or online as they navigate the criminal justice system, Title IX process, or seek civil remedies for harms they've endured. She co-founded a nationwide working group of Title IX practitioners and advises students impacted by sexual misconduct on campus. She also represents individuals who have experienced discrimination and harassment in the workplace, and in negotiating employment, severance, and separation agreements.

Ms. Gandy has extensive trial experience in federal and state court. She served as a federal prosecutor at the U.S. Attorney's Office for the Eastern District of New York for eight years, including as Deputy Chief of the Organized Crime and Gangs Section. As a federal prosecutor, Ms. Gandy investigated and prosecuted sophisticated criminal organizations engaged in racketeering offenses, as well as individuals involved in sex trafficking, production of child pornography, murder, fraud, and corruption. Her efforts twice earned her Prosecutor of the Year awards from the Federal Law Enforcement Association, and the True American Hero Award from the Federal Drug Agents Foundation.

Prior to her work as a federal prosecutor, Ms. Gandy was an Assistant District Attorney at the Manhattan District Attorney's Office, where she conducted extensive and often complex investigations, including those related to organized crime, international drug trafficking, and money laundering. She first served in the Office of the Special Narcotics Prosecutor where she was awarded a commendation for Extraordinary Service. She later served in the Rackets Bureau where she investigated and prosecuted organized and white-collar crimes and public corruption. She prosecuted the first case in New York county charging a violation of the state terrorism statute.
